Mr. Miller reviewed the unaudited financial statements through March 31, 2024. He reported that revenues are in line with budget expectations. Total assets as of March 31, 2024, were \$19.4M. All administrative budget line items except Legal are currently running below budget.

Mr. Miller stated that the current assessment period is in progress with a May 15, 2024, period due date. This period reflects the higher CY2024 assessment rate of \$12.50. Ms. Meagher reported that as of April 16, 2024, 50 of the 175 filings expected were received, representing approximately 11% of the estimated covered lives for the quarter. Several filings are the required null filings for Q1 CY2024.

Mr. Miller stated that he will be meeting with Ms. Mercuri in early May to confirm the June 2024 payment amount. As of March 31, 2024, a total of \$18,452,169 has been expended by the state this fiscal year for the NHVA's portion of vaccines.
